Decision to forego the Catalyst Grant Project for this year.

Proceeding forward with the park shelter grant. Will need to apply for WTAP Grant next year. No additional ED goals for FY 24. It was decided to proceed forward with the Franchise Fee agreement with Alliant Energy at 3% for 15 years. The TIF program will not be able to begin until July 1, 2024.

Budget Certification Meeting will be April 22, 2024 at 7 PM.

OB: Delinquent water bills. 10 Letters will be prepared for sending. There were 5 shut offs that were completed.

Nuisance Properties: The attorney is working on the property at 315 N Elm St. The attorney is working on getting the lien released.
